This list was generated in order to ensure access to the comments as a means of ensuring that those who wrote would be easily contacted given the possibility that SJC will delete this information as “no longer relevant” and thus only accessible via a PRR. My experience with a PRR requesting similar data was necessitated because DCD

removed a VRP comments web page because “the issue was no longer relevant and DCD did not want the public confused” (I believe this is what Erika Shook revealed to me in an email some years ago when the VR regulations topic in 2018 was being processed.) When I discovered the missing page and filed a PRR for getting the comments, I received a tiny fraction of what was originally posted on the county’s web site.
